#### Public Questions.

I would like to ask if the council could put a speed restriction on the lane running down to Musty Haulgh farm. I know it's unlikely as it's a private road and LCC are responsible for highways but I think the increasing risk to pedestrians needs to be addressed and perhaps there are other things you can do. The potholes do slow some cars down but they also cause the cars and many heavy goods vehicles to swerve in erratic ways.

The increase in traffic since the development of Bend Hill Farm has to be experienced to be believed.

A. Unfortunately the Parish Council does not have the powers to install speed restriction as this is a County Council function, however it will pass on your concerns to our County Councillor. Councillor Gordon Lishman added that he felt the Council should support the resident.

Hi was wondering why there are so many empty allotments which look a mess. And how long do we have to wait to get one please. I have already applied and when I go up the empty ones are still empty.

A. There are currently no allotments that have been handed back to the Council, however site inspections are taking place now the growing season has started and untidy plots will receive letters about this.

Please could I address the meeting on Tuesday about the issue of traffic and parking on Kimberley Close. The street signs on Kimberley Close and Kimberley St used to indicated that it is a cul de sac. These were never replaced when new signs were put in place. It seems like sat navs are taking vehicles up Brunskill Street and into Kimberley Close giving the impression you can get through to the barn situated above the Close. Also we get a lot of vehicle going really fast in and out of the Close. We had what could have been a very serious incident a few weeks ago and I have found it impossible to get though to any person at LCC Highways.

This is an issue that has been raised on a number of occasions over the last 20 years.

A. Again we will ask our County Councillor to look into this issue. Councillor Gordon Lishman added that he felt the Council should take this issue up with the relevant Department and support the resident.

### Briercliffe Parish Council Borough Councillors' Report – April 2022

**Election:** As well as the Parish Council election there was the election for a Briercliffe representative on Burnley Borough Council. Gordon Lishman was elected for another term.

Fly-tipping and Dumping: We have dealt with the usual things this month There have been some large and regular fly tipping on Ridehalgh Lane and Widdop Rd. We have reported each incident to Streetscene and they usually clear it quickly. We ask that if people see any flytipping or dumped rubbish that they take a photo and forward it to us with exact details of where it is. Some of the incidents are over the border in Calderdale and we have passed on information. Some of the rubbish recently has been cannabis residue and the police are informed because it can be dangerous to fish and wildlife if it gets into rivers.

**Planning:** We share the concern of residents about the proposed change of use for Arncliffe at Hill End, particularly around access.

**Floods:** The work appears now to have been completed at the top of Holgate Street. We shall now have to wait for the next heavy rain storm to judge how many of the problems have improved. It should have dealt with the big problem of the flooding, but it seems likely that other problems will continue because there is simply too much water coming off the fields because of the changing climate. The problems at Rockwood Close seem to be spreading more widely, now down as far as Netherwood Street and Talbot Drive. The County has been unblocking drains and says they will put right the damaged roads and pavements. We are not holding our breath!

Lane Bottom Park: We are still waiting for the play equipment to be delivered to Lane Bottom Park. It has all been bought and we're just waiting for it to be fitted. Anne keeps nagging and they've promised to come as soon as they can. A few years ago, when the boundary stones were sited, Simon Dack kindly delivered a huge piece of stone at the park gate. Please would the PC consider putting a plaque on with the name of the park? There doesn't appear to be an official name (although Roger will know), but it would be good to see something.

Parking Enforcement: officers have been busy ticketing vehicles who park on double yellow lines and too near to corners. At the top of Talbot St where resurfacing work was done, the lines have not been repainted and drivers are quick to take advantage. It makes it impossible for the big Spar lorries to turn into Talbot St. We have asked that they are replaced urgently.

**Burnley Mayor:** Tomorrow is Mayor making at Burnley Town Hall when Councillor and County Councillor Cosima Towneley will be installed as Mayor for the Municipal year 2022-23.
